Please arrive with clean, dry hair to help the hold of your hair style

Bring any inspiration pictures of makeup and different hairstyles for your stylist to refer to

Please bring any headpieces, veil, and accessories to try on during your trial run

On the day of the wedding, you are invited to bring any food and drinks that you feel will make your day more special

For your wedding day we can operate before our normal business hours for your convenience. A fee of \$50 per person may apply prior to 7:00 am

For any makeup services, we partner with a local makeup artist. Therefore, it is not always guaranteed that they are available on your specific date. Please schedule your services at least 4 months in advance to ensure their availability. We will also work with you to schedule any trials with the makeup artist. Makeup pricing is at the artists discretion



Important Events

Complimentary Consultation

Here we will discuss your hair and makeup needs as well as schedule both your trial and wedding day services. Our contract and cancellation policies will be reviewed. Due to summer wedding dates being more popular, we recommend that your wedding services are booked 4 months in advance.

Bridal Hair Trial

Your trial should be scheduled 3 to 4 weeks prior to your wedding date. You should bring any additional elements that you will wear on your wedding day. This includes your veil, jewelry, etc.

Wedding Day Hair/Makeup

We'll recreate the look we achieved during your trial to make you feel absolutely beautiful on your wedding day!

Make-up Consultation and Trial

Since we partner with a local makeup artist for our bridal services we will assist you in getting into contract with the artist to schedule any trials or consultations.

Making Payments

We at Hair Bizz Inc. want to make the payment process as smooth as possible to ensure no stress is added to your big day. We ask that all payments are made to a designated person, this person will then Hair Bizz inc.. Payments can be accepted by Zelle, Venmo, or Cash. All Services are priced at a per person rate and include the use of professional hair and make-up products and supplies. The pricing per person does not include of travel
